- 4. That no part of income from the institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5. That school is not paying any charges towards using name, motto, logo or any other non- academic activities to any other institution, organization or body organization.
- 6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examinations bylaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provision contained in the affiliation & examinations bylaws, directions issued from time to time and the law of the land.
- 8. That the school will ensure compliance of all statutory like, EPF, ESI and Labor Laws etc. with respect to the school and staff of the school.
